1. PERSONAL DATA THAT WE PROCESS

Axces BV processes your personal data because you make use of our services and/or because you provide them to us yourself. Below you will find an overview of the personal data we process:

2. SPECIAL AND/OR SENSITIVE PERSONAL DATA THAT WE PROCESS

Our website and/or service has no intention of collecting information about website visitors under the age of 16. Unless they have parental or guardian permission. However, we cannot verify whether a visitor is over 16 years of age. We encourage parents to be involved in their children's online activities in order to prevent the collection of information about children without parental consent. 3. FOR WHAT PURPOSE AND ON WHAT BASIS WE PROCESS PERSONAL DATA

Axces BV processes your personal data for the following purposes:

- Processing your payment
- Sending our newsletter and/or brochure
- To be able to call or e-mail you if this is necessary in order to carry out our services
- Inform you about changes to our services and products
- Allow you to create an account
- To deliver goods and services to you
- Axces BV analyses your behaviour on the website in order to improve the website and to adjust the offer of products and services to your needs.

- Axces BV follows your surfing behaviour on various websites with which we tune our products and services to your needs.

- Axces BV also processes personal data if we are legally obliged to do so, such as data we need for our tax return.

4. AUTOMATED DECISION-MAKING

Axces BV does take decisions on the basis of automated processing on matters that can have (considerable) consequences for persons. These are decisions that are made by computer programs or systems, without a person (e.g. an employee of Axces BV) in between. Axces BV uses the following computer programs or systems: Google Analytics, because of the analysis of web visitors on both the website and webshop. Based on these results, decisions will be made to change relevant matters, so that the website and/or webshop can be improved for the person concerned.

5. How long we keep personal data

Personal data is stored in accordance with the internal storage policy of Axces BV and/or as long as (i) the customer relationship lasts, (ii) Axces BV is legally obliged to store the data, or (iii) Axces BV is of the opinion that there are good grounds to store data, for example for warranty claims.

6. SHARING PERSONAL DATA WITH THIRD PARTIES

Axces BV shares personal information with third parties in the following cases and with the corresponding reasons:

- with affiliated financial service providers;
- with authorised dealers or service partners of the Axces BV distribution network;
- in the event of a legal obligation or authority to provide personal data to third parties;
- in case of suspicion of violation of the rights of third parties, criminal offences or abuse, Axces BV can provide personal data to third parties with a legitimate interest or to entities that serve the public interest. This may involve law enforcement authorities, such as the Public Prosecutor's Office or regulatory authorities;
- Axces BV can also share data with other business units within Axces BV for the execution of agreements, or for legitimate business interests, such as carrying out central administration or customer service and analysing services;
- with parties who assist Axces BV in its services and who are not processors (such as accountants and (legal) advisors);
- for economic purposes (such as the sale of business activities or shares, or restructuring).

7. COOKIES, OR SIMILAR TECHNIQUES, THAT WE USE

Axces BV uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone the first time you visit this website. Axces BV uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to optimize it. We also place cookies that keep track of your surfing behaviour so that we can offer tailor-made content and advertisements. On your first visit to our website, we already informed you about these cookies and asked permission to place them. You can unsubscribe from cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via your browser settings. 8. VIEW, MODIFY OR DELETE DATA

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your possible consent for the data processing or to object to the processing of your personal data by Axces BV and you have the right to data transferability. This means that you can submit a request to us to send the personal data we hold about you in a computer file to you or to another organisation named by you. You can send a request for inspection, correction, deletion, data treatying of your personal data or a request to withdraw your consent or objection to the processing of your personal data to info@axces.com. To ensure that the request for inspection has been made by you, we ask you to enclose a copy of your proof of identity with the request. In this copy, make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Burgerservicenummer (BSN) black. This for protecting your privacy. We will respond to your request as soon as possible, but within four weeks.
